MISCELLANEOUS INFORMATION

- 1. The link to the geotechnical addendum letter was incorrect and has now been corrected. If you downloaded the file previously, please disregard. Correct letter is attached to this addendum.
- 2. Where geotechnical recommendations exceed what is indicated on the drawings the geotechnical recommendations shall apply. For example, civil drawings show pool deck to be 6" concrete over 4" aggregate base, but the geotechnical recommendation is to over-excavate 12" and provide structural fill material. The geotechnical recommendation shall apply.
- 3. Pool Equipment Budget is attached.

- 1. Added model for diaper changing station to be Koala Kare KB300-SS.
- 2. Delete old version of Div 13 specs (dated 11/11/22).
- 3. Added 321313 Concrete Paving.

PLANS

- 1. Civil:
 - a. Expected spoils is 700 CY. The District will allow for the field north of the pool site to be raised approximately 18 inches. Any additional spoils must be removed from the site by the contractor.
 - Added pool deck construction, sheet C301. Concrete for pool deck shall be 4,000 psi min. w/ a slip-resistant, non-abrasive finish.
- 2. Architectural:
 - a. Chain Link Fencing: Revised Details 1, 2 & 3 to include maximum post spacing and increased footing depths. Reduced fabric gauge from 6 Ga. to 9 Ga.
 - b. Added signage to exterior elevation, 7/A3.1.
 - c. Revised Detail 1/A9.1. Diaper Changing Station requires (6) screws, not (4).
 - d. Change wall stops to floor stop at doors 101A, 102A & 104A. Add floor stop at door 103A. Delete wall stop at doors 101B, 105A, 106A & 107A. Floor stops shall be Trimco 1258M or approved equal.

Clarification Questions:

- 1. Where are the spec sections for divisions 310000, 320000 & 330000? Looks like they're missing from Project Manual, please provide.
 - a. The Civil engineer feels that they do not need specifications. All necessary information for their work is shown on their drawings.
- 2. There are two spec sections for swimming pools, assuming we're to bid per the one dated 7/11/23 not the one dated 11/11/22. Please advise.
 - a. Correct. Use the most recent version. Delete the older version.
- 3. Are all permits by owner?
 - a. Permits will be paid by the Contractor as noted in the specifications.
- 4. Does the existing shade structure remain? Plans call for us to protect it.
 - a. The existing shade structure is outside of the project scope and should not require special protection during construction activities.
- 5. Will you consider changing the GC change order markup on subs to 10%? 5% even doesn't cover GC general conditions.
 - a. Markup will remain unchanged.
- 6. Is there any Landscaping included in this project?
 - a. No.
- "Hammerhead fire apparatus access road turnaound" as shown on page A1.1, isn't shown on Civil pages. Please provide civil details.
 - a. Hammerhead turnaround has been removed.
- 8. Confirm there are to be no lock protectors, thresholds or weatherstrips at any of the exterior doors. We usually do see thresholds & weatherstrips at exterior doors.
 - a. The project does not currently include lock protectors. Weatherstrip and door bottoms are called out on A2.0 and are to be provided for all exterior doors. Roll up door shall also include full perimeter weatherstripping and bottom door seal. Saddle thresholds are not shown on the door hardware schedule because doors have angle thresholds as shown in 4/A8.1.
- 9. Openings 105B, 106A & 107A will need some kind of astragal for these pairs of doors. Confirm these openings to have astragals.
 - a. Provide Pemko 357SP with S88 and tamper-resistant through-bolt astragal or equal at each door pair.



TO ALL BIDDERS:

The following changes, omissions, and/or additions to the Proposal shall apply to proposals made for and to the execution of the various parts of the work affected thereby, and all other conditions shall remain the same.

All parties of interest shall take careful note of the addendum so that the proper allowances may be made in strict accordance with the Addendum.



In case of conflict between bid documents and this addendum, this addendum shall govern.

Clarification Questions:

- 1. Is the structural steel to be shop primer or galvanized? Specs call out both.
 - a. Structural steel shall be shop primed per Structural Steel note #4 on Sheet S1.1.
- 2. What is the thickness of the concrete pool deck? What depth & size of base under concrete? Please clarify & provide details. *Civil plans (pg. C201) says to see Architectural & Pool Plans. Architectural plans (pg. A1.3) says to see Civil drawings. Pool plans (pg. SP1.0) says to see Architectural.
 - a. Refer to Addendum 1. Addendum #1 includes a revised Civil drawing C301 which added a description of minimum requirements for the pool deck construction. Addendum #1Miscellaneous Information item #2 provides clarification that the Geotechnical recommendations exceed the minimum requirements for the pool deck and take precedence over the Civil engineer's drawings.
- 3. Please provide more information on the data equipment.
 - a. For bid clarity, all data equipment and cabling will be done by the Owner and is removed from this project. The contractor shall only provide the infrastructure required (e.g., mounting surfaces, pathways, conduit, and boxes) for data cabling that is shown in the drawings.
- 4. Plan Sheet SP3.0 shows 10" gutter gravity drain piping to surge tank, however, sheet SP4.3 detail #1 shows gutter piping as 8". Please clarify size of gutter pipe as it enters surge tank. Does the pipe reduce down from 10" to 8" as it enters surge tank?
 - a. Gutter gravity drainpipes and their link seals shall be 10" diameter.
- 5. Plan sheet SP.6 shows typical underwater light detail and UWL Junction Boxes mounted to wall or a bollard at 8" min above pool deck. However, Electrical sheet E200 shows multiple junction boxes (one per light) that appear to be flush mounted within the pool deck. Please provide qty of lights per JB, make/model of JB, and locations of pool UWL junction boxes required if they are to be mounted per Sheet SP.6 (8" above deck). Are the junction boxes to be mounted against the perimeter fencing and or against mech. room building? If so, do the JBs need to be mounted inside a concrete bollard or fixed to post that is 8" above the deck? If so, provide detail for UWL junction box bollards and their proposed locations that does not impede path of travel around the pool deck.

- a. Provide revised conduit routing shown on E200. In lieu of deck-mounted junction boxes, provide tombstone risers per attached detail.
- 6. Have the pool plans been approved by the Health Department?
 - a. All comments from the County Environmental Health department have been resolved; however the department will not issue their approval until the Contractor is selected.
- 7. Typically, the health department & CA Pool Code requires hose bibbs around the pool deck for maintenance. Are hose bibbs required? I do not see them on the Pool nor Plumbing plans.
 - a. There are two (2) water hydrants on the building. In addition, run 1" Schedule 40 PVC from the water service connection point at the north side of the building (see C401) along the north, east, and south sides of the pool deck not more than 1-foot from the deck edge. Provide a total of three (3) galvanized hose bibbs and risers with metal stake supports at the fence line. Wrap risers for freeze protection. Locate one (1) hose bibb centered on the east deck edge and two (2) hose bibbs equally spaced along the south deck edge.



8. The Geotech Report states the following: If groundwater or saturated soils are encountered during construction or are anticipated in the pool area at any time of the year, a hydrostatic pressure relief system should be installed in the deep end of the pool and the pool should be underlain by a minimum 6-inch thick layer of 3/4-inch clean gravel underlain by Mirafi 140N filter fabric, or Caltrans Class II permeable material.

A 4-inch diameter perforated Schedule 40 PVC or ABS pipe should be installed in the gravel at the deepest point. The perforated pipe should slope at a 2 percent minimum grade to a tight line at the edge of the pool that carries the drainage to an observation well where water can removed by pumping. Per the Geotech report, is the contractor to assume the 6" layer of ¾" drain rock under the pool and the 4" perforated pipe to an observation well may be needed and shall include in their base bid price?

- a. Yes, the Contractor shall install the gravel, filter fabric, and observation well.
- 9. The surge tank access hatch shown on SP4.3 detail #3 is not a flush mounted installation and is a potential tripping hazard. We suggest using a flush mounted concrete in-fill access hatch manufactured by Bilco or equal. Would this be acceptable in lieu of the specified Dal Dorado hatch? Furthermore, Division 13 specifications state a 24" x 24" access hatch, however, plans show a 36" x 36" access hatch. Please clarify dimensions for hatch.
 - a. The Dal Dorado hatch (or approved equal) access hatch will be installed flush. Delete benches shown in detail 7/A1.4.
- 10. Sheet SP2.3 detail #6 shows (2) 1Meter diving boards. Plans/Specifications do not list specified diving board make, model, etc. Please provide specified manufacturer for diving boards and model #.
 - a. The diving boards shall be Duraflex 16-ft aluminum springboards, Model #66-231-330 with Duraflex 1-meter stands, Model #70-231-400. A cut sheet for the boards is in the Equipment cut sheet packet.
