IPM statement

It is the goal of Pierce Joint Unified School District to implement IPM by focusing on long-term prevention or suppression of pests through accurate pest identification, by frequent monitoring for pest presence, by applying appropriate action levels, and by making the habitat less conducive to pests using sanitation and mechanical and physical controls. Pesticides that are effective will be used in a manner that minimizes risks to people, property, and the environment, and only after other options have been shown ineffective.

Our pest management objectives are to: *(Example: Focus on long-term pest prevention)*

We strive to create and sustain a "pest-free" learning environment and to use the least intrusive methods to remove and eradicate pests that supports student health and safety.

Pest identification, monitoring and inspection

Chemical pest management practices

This school district expects the following pesticides (pesticide products and active ingredients) to be applied during the year. (This list includes pesticides that will be applied by school district staff or licensed pest control businesses.):

Alpine: (Dinotefuran) EPA#449-56; Upcyle: (Cypermethrin) EPA# 70506-19; Rodent Bait: (Diphacinone) EPA# 56-74; Excitri: (Pyrethrin) EPA#89459-41; Nyguard: (Pyridine) EPA#1021-1603.

Training

Submittal of pesticide use reports

- Reports of all pesticides applied by school district staff during the calendar year, except pesticides exempt¹ from HSA recordkeeping, are submitted to the Department of Pesticide Regulation at least annually, by January 30 of the following year, using the form provided at www.cdpr.ca.gov/schoolipm. (Education Code Section 16711)

¹ These pesticides are exempt from all Healthy Schools Act requirements, except the training requirement: 1) products used in self-contained baits or traps, 2) gels or pastes used as crack and crevice treatments, 3) antimicrobials, and 4) pesticides exempt from U.S. EPA registration. (Education Code Section 17610.5)
